I. Call to Order and Roll Call

Committee Chair, Jennifer Shipman called the June 7, 2021 meeting of the Youth Development Committee (YDC) to order at 1:02pm. Roll call of Committee members was completed.

II. Conflict of Interest

Committee Chair, Jennifer Shipman reminded Committee members of the Conflict of Interest Policy.

III. Public Comment Period

There were no public comments on non-agenda items.

IV. Chair Report

A. STANd OUT! Youth Leadership Event Planning Committee Committee Chair, Jennifer Shipman gave an update on the STANd OUT! Youth Conference planning progress, and shared that the Conference will be on Friday, July 23, 2021 from 8:00am–4:00pm at the Martin G. Petersen Events Center on 12th Street in downtown Modesto. STANd OUT! Youth Conference is designed to involve youth ages 18-24 that are enrolled in primarily Ceres Unified School District's Project YES and the Stanislaus County Workforce Development (SCWD) Summer Youth Employment Program. This motivational day-long program, will involve several speakers and workshops, that will be dedicated to the empowerment of these young adults that we hope that will help in their in goal-setting, and overcoming life's obstacles, challenges and barriers. The Committee is expecting approximately 75 youth participants and 4 speakers to be involved as COVID-19 restrictions limit the attendance numbers. There will also be several Community Service organizations that will also be involved in the event. The planning group is very excited to bring this event to the youth of Stanislaus County, and are planning to make STANd OUT! Youth Conference an annual event.

V. Department Report

- A. CUSD "Project YES" program report
 - Cynthia Mejia of Ceres Unified School District's Project YES presented an overview of the agency, statistics, and the services provided, along with the challenges brought by COVID-19 and distance learning.
- B. Summer Youth Employment Program Update
 Ryan Gonchar, Summer Youth Employment Program (SYEP) coordinator
 reported that he and his staff are still accepting applications for the Program
 until June 23, 2021. Youth will be placed at job sites beginning in July and the
 summer jobs will last approximately 8 weeks. Due to COVID-19, the enrollment is
 lower than expected at this point.
- C. WIOA 2021-22 Youth Allocation/Funding Update
 Workforce Manager, Adolph Lopez shared the upcoming Fiscal Year (FY)
 2021-2022 Youth Funding allocation and distribution showing the 2021-2022 reduction in funding.
- D. Youth Development Committee Youth Representative Vacancy Workforce Manager, Adolph Lopez reminded Committee members that there is still a vacant seat on the Youth Development Committee for a Youth Representative, and requested Committee members to submit names of qualified candidates to his attention.

VI. Presentation

A. SCWD Youth Probation "Let's Work!" Program

Workforce Supervisor, Blane Takasaki and Workforce Specialist Teresa Brockman gave a presentation on the "Let's Work!" Youth Job Readiness Program. Let's Work! helps justice-involved clients develop skills such as job search, effective communication, problem solving, resume building and interviewing. The Program is in conjunction with the Probation Department and is available to In-Custody (Ages 15-18) and Out-of-Custody (Ages 16-18) clients upon referral from their Probation Officer. Since 2018, the Program has served 153 In-Custody clients, and 78 Out-of-Custody clients. Many of the 78 Out-of-Custody clients have been placed in jobs.


