A. Industry Snapshot

The North American Industry Classification System (NAICS) is the standard used by Federal statistical agencies in classifying business establishments for the purpose of collecting, analyzing, and publishing statistical data related to the U.S. business economy. For this report, the industries examined are represented by the first 2 digits of the NAICS Code, which shows us the overall industry, rather than industry sub-sector information.

I. Employment

For 2-NAICS-digit level, based on figure A.2 and A.3, the top ten sectors that had the largest employment in 2020 were:

- 1. Health Care and Social Assistance
- 2. Government
- 3. Retail Trade
- 4. Manufacturing
- 5. Accommodation and Food Services
- 6. Agriculture, Forestry, Fishing and Hunting
- 7. Construction

- 8. Transportation and Warehousing
- 9. Administrative and Support and Waste Management and Remediation Services
- 10. Other Services (except Public Administration)

Health Care and Social Assistance had the largest employment among all industries in Stanislaus County in 2020 with 33,128 workers (figure A.1 and A.2). The sector is forecasted to have employment growth of 5,370 employees or about 3.05% of the annual growth rate in the next 5 years (figure A.3).

Government sector ranked 2nd with 30,793 employees in 2020 (about 15.9% of the total Stanislaus county employment). *Government* sector includes many subsectors such as

- US Postal Service, Civilian, and Military (Federal)
- Education and Hospitals (Local and State Government)
- Non-Education and Hospitals (Local and State Government)

Manufacturing ranked 4th in the top ten sector list with about 10.9% of the total Stanislaus County employment. However, the 5-year anticipated data shows that the number of employees will decrease by (-309), and the annual growth rate is expected to be (-0.29%) (figure A.3).




Figure A.1: Top 10 2-digit sectors with the largest employment in Stanislaus County in 2020 (Source: EMSI)

II. Average Annual Wage

Figure A.4 indicates that the average wage per worker in Stanislaus County in 2020 was \$51,667, about \$9,000 lower than the national annual wage of \$60,761 and \$22,500 lower than the California state annual wage of \$74,294.




Figure A.4: Average Wages per worker in the U.S Nation, California State, and Stanislaus County in 2020 (Source: EMSI)

Manufacturing employees got the highest compensation, an average of \$65,662 in Stanislaus County in 2020, while it ranked 4th in the top ten largest employment list.

Health Care and Social Assistance workers earned the second-highest average annual wage with, \$63,403.

Construction sector, with only 10,155 employees, brought to the workers an annual income of about \$62,197 in 2020.

Although *Government* sector had the second largest employment, the workers in that industry earned an average annual wage of \$58,295 in 2020, which was lower than *Manufacturing*, *Health Care and Social Assistance*, and *Construction* workers.

Accommodation and Food Services employees earned the lowest average income among the top 10 sectors, about \$20,218 per year.

Figure A.5 illustrates the average annual wage trend of the top 10 industries in Stanislaus County, and figure A.6 shows the annual growth rate of the average annual wages from 2010 to 2020. Notice that all lines were moving upward over time.

Although *Health Care and Social Assistance* was always in the top 2 occupations with the highest annual salary, its growth rate was the lowest among all, only 1.46% per year (figure A.6), which means that the wages of the *Health Care and Social Assistance* workers had not raised much from 2010.

In the last 8 years (2012 - 2020), *Manufacturing* line moved above other sectors. The value rose from \$51,247 in 2010 to \$65,662 in 2020. The annual growth rate from 2010 to 2020 was 2.51%.

Agriculture, Forestry, Fishing, and Hunting average annual wage had surged the most, about 4.65% each year (figure A.6) from \$25,692 in 2010 to \$40,493 in 2020.

Accommodation and Food Services line was always below other sectors, and it also looked flatter than the others, indicating that over the past 10 years Accommodation and Food Services workers had been receiving the lowest average income compared with other top 10 sectors, and the pay rate had not increased significantly.




Figure A.5: Average annual wage trend of the top 10 industries in Stanislaus County from 2010 to 2020 (Source: EMSI)



Column Definition:

- Wages, Salaries, & Proprietor Earnings: The average annual wages for the designated subsectors.
- **Employment Change**: The forecast employment growth demand over the number of projection years selected by the user.
- Annual Growth Rate: The forecast average annual growth rate. This measure can be computed by the following formula: ((Current Employment + Growth Employment) / Current Employment) ^ (1/# of years) - 1

B. Economic Facts

Figure B.1 shows the Gross Regional Product of the ten industries with the largest employment in Stanislaus County in 2020 ordered by the *2020 Property Income/Profits*. "Earnings" column illustrates the total industry earnings for a region, including wages, salaries, supplements (additional employee benefits), and proprietor income.

Health Care and Social Assistance had appeared to be the most attractive sector for workers due to its high demand and huge potential growth rate. The profit from *Health Care and Social Assistance* was not significant compared to its earnings in 2020. The main reason was the high cost of medical labor and tools. The 2020 Earning was \$2,677,382,755, which was the highest-earning amount among the top industries, and the 2020 Profit was \$561,689,131.

Manufacturing had the greatest profit among all top industries in Stanislaus County. The earnings ranked 2nd while the profits ranked 1st in the table. About \$1,695,830,209 was created as profit from *Manufacturing* activities. Furthermore, *Manufacturing* sector received an amount of \$163,232.00 in subsidies in 2020. As a result, considering economic factors alone, *Manufacturing* was the most beneficial sector to invest in.

Agriculture, Forest, Fishing and Hunting received the largest total subsidies from the government. The grants amounted to \$808,481,091 in 2020.

Government sector had a huge earning of \$2,662,211,802 and received the total subsidies of \$24,354,453 in 2020.

<u>Question 1</u>: Among the top ten sectors, which sector will create the greatest economic impact if adding 1,000 jobs to it?

Figure B.2 is calculated based on the NAICS 6-DIGIT Industry report on EMSI. On average, adding 1000 jobs to Agriculture Industry will create 338 other jobs.

Health Care and Social Assistance has appeared to be the most attractive sector for workers due to its high demand and huge potential growth rate. The expansion of 1,000 jobs in *Health Care and Social Assistance* can make the addition of 412 positions to the industry.

It is interesting that adding 1,000 positions to *Government* has the greatest economic impact on Stanislaus County. It can lead to an addition of 710 open jobs in the area.

Transportation and Warehousing is another outstanding sector to look at. About 547 positions will be added as a result of the expansion of 1000 jobs in the sector.




Figure B.2: Average Total Employment Impact on the top ten sectors of Stanislaus County in 2020 (Source: EMSI)

Question 2: Among the top ten sectors, which sector will create the greatest economic impact if adding \$1,000 to it?

Figure B.3 is calculated based on the NAICS 6-DIGIT Industry report on EMSI. On average, for every \$1000 fed into *Retail Trade*, it will lead to an additional of \$153.10 in Sales.

Manufacturing had the least ripple effect when it can add only \$127.81 on every \$1000 adding to the sector while table B.1 shows that *Manufacturing* created the highest profits in 2020.




Figure B.3: Average Total Sales Impact on the top ten sectors of Stanislaus County in 2020 (Source: EMSI)

Column Definition

- Taxes: Taxes on production and imports with subsidies subtracted.
- Subsidies: Money granted by the government to assist an industry or business.

C. Occupation

I. Health Care and Social Assistance.

Figure C.1.1 illustrates ten *Health Care and Social Assistance* occupations with the largest employment in Stanislaus County in 2020. Some careers in the list had remarkable projected employment growth in the next 5 years, indicating the potential of expansion shortly.

Home Health and Personal Care Aides ranked 1st in the list with 5,042 current workers. About 1,630 open positions are anticipated to be added by 2025, leading to a total demand of 6,672 employees. The low level of Median Annual Earnings, approximately \$28,100.80 per year, might be an essential reason for the high demand of *Home Health and Personal Care Aides* occupational group since employers would favor skillful health care workers who only received minimum pay rate.

The top 10 *Health Care and Social Assistance* occupations were not well-paying except for *Licensed Practical and Licensed Vocational Nurses* at \$58,676.80 per year, and *Registered Nurses* being \$110,177.60 per year.

II. Government

Notice that educational services that come from Federal/State/Local government educational institutions in EMSI were categorized in *Government* sector instead of *Educational Services* sector (Chmura).

Teaching Assistants, Except Postsecondary was the most popular occupation in *Government* sector with 2,537 employees in 2020. However, it was not a well-paying job with a median annual salary of \$34,410.00 per year (figure C.II.1).

Some occupations in table C.4.1 were paid well, such as *Elementary School Teachers, Except Special Education*, \$88,630.00 per year, *Postsecondary Teachers*, \$83,162.56 per year, and Secondary *School Teachers, Except Special and Career/Technical Education*, \$89,410.00 per year. Please note that the educational levels necessary to enter this industry classification were more stringent than many other industries, with most teaching positions requiring a BA Degree and a teaching credential, or a graduate degree and an Administrators Credential.

III. Retail Trade

The ten occupations with the largest employment in Retail Trade are shown in figure C.III.1.

Question: Is Retail Trade a good sector to build labor force?

According to the 5-year forecast, the top-10 occupations' employment growth rates were very few compared with the size of the employment in 2020. It could be understood as those occupations already reached their maximum size and are expected to not expand/slightly shrink in the near future.

For example, the demand for *Cashiers* is anticipated to decrease by 2025. The expected employment change is (-98) positions while the expected total demand is 5,116.

The salaries of all occupations in the list, except for *General and Operations Managers* with \$93,080.00, were lower than the county's average wage per worker (\$52,772 from figure A.4)

The anticipated fastest-growing job is *Retail Salespersons*, which will have an employment growth of 128 employees by 2025. Other most growing jobs are projected to add very few positions comparatively.

Critical Conclusion: Retail Trade in Stanislaus County is predicted to not expand its size in the next few years. Therefore, most new demand comes from workers who would exit the workforce or transfer into different occupations. Since there is a fair number of forecasted total demand, it might still be an average sector to invest in.

IV. Manufacturing

Manufacturing had been impressive due to its rapid growth in salary level and remarkable economic profit in 2020 (figure B.1); however, projections show an overall employment decline in the sector. The occupation with the highest number of employees was Manufacturing was Packaging and Filling Machine Operators and Tenders (figure C.IV.1) with 1,687 workers and it is expected to decline by (-38) employees.

V. Accommodation and Food Services

The anticipated total demand of *Fast Food and Counter Workers* is remarkable, about 5,177 workers would be employed in 2025 (figure C.V.1). The anticipated employment growth of the job is about 510 positions.

Regardless of the high demand of *Fast Food and Counter Workers* in 2025, the number of *Cooks, Fast Food* occupations is estimated to decrease by 75 employees.

Interestingly, although *Cooks, Restaurant* occupations is forecasted to grow (employment change 139 open positions in the next 5 years), the growth of other restaurant occupations is either low or negative; for example, waiters and waitresses, cashiers, dishwashers, etc. It is possible that a worker would take multiple tasks and some other processes would be taken care of electronically.

VI. Agriculture, Forestry, Fishing and Hunting

Most *Agriculture, Forestry, Fishing and Hunting* workers worked in *Farmworkers and Laborers, Crop, Nursery, and Greenhouse* occupational group, with around 7,652 employees in Stanislaus County in 2020. Figure C.V.1 indicates that about 265 positions will be added as of 2025, leading to a total demand of around 7,918, employees. Another outstanding point is that the median annual wage for the job was the third lowest in the table.

On the other hand, Agricultural Workers, All Other ranked 5th in the table. Its median annual wage is fairly high, around \$70,166.36 per year. It is anticipated that there will be 501 positions for this career in the next 5 years, decreasing by 9 employees as compared to 2020.

Observe that except for Farmworkers and Laborers, Crop, Nursery, and Greenhouse, other occupations in figure C.V.1 had only few or negative numbers of open positions in 2025.
