#### VI. Informational Items

A. Presentation: Stanislaus County Office of Education "Come Back Kids"
Youth Development Committee member Cindy Young gave an overview of the "Come Back Kids" program offered by the Stanislaus County Office of Education that offers a high school program for adults (ages 18 and above) who want to come back to receive a high school diploma. This is an independent study format with online courses and weekly meetings with staff. The program also offers Career Readiness classes as well as College Readiness classes to give participants the tools needed for success in the job market or in pursuing higher education. The program graduated approximately 200 students last year.

B. AJCC Overview

Analyst Andy Fiskum presented a PowerPoint on "America's Job Center of California" (AJCC). He touched on partner's roles and responsibilities, strategies and WIOA regulations affecting our local AJCC One-Stop Centers.
